

Introduction:

The public availability of company information varies from jurisdiction to jurisdiction and when carrying out due diligence research it can often be a time consuming exercise to ascertain exactly what information is available online and what must be requested directly from a company. The ID Register has compiled a user friendly list of the type of information which is available free of charge in different jurisdictions and the steps necessary to obtain these documents where the website is not available in English. Many of the sources listed below also provide official company documentation for a fee.
